Key messages:

- 1. Seminar for LBAP partnerships to be held in September 2010 to introduce marine targets and actions. Separate workshops for north and south.
- 2. WAG to resign as chair of the Marine Ecosystem Group. In exchange for this, the head of Fisheries (Graham Rees) and the head of Marine Policy Branch (Julia Williams) have agreed to attend and participate in the work of the Wales Biodiversity Policy Group. Louise George from the Marine Policy Branch and a representative from WAG Fisheries Unit are to be members of the Marine Ecosystem Group. Diana Reynolds has agreed to attend the MEG in a years time to discuss how this arrangement is working. Members agreed DR's nomination of Blaise Bullimore (rep for Group of European Marine Sites (GEMS) & Carmarthen Bay and Estuaries officer) for chair of the MEG in the interim. Criteria for success of the arrangement were agreed to be active participation of both Marine Branch and Fisheries Unit in the Marine Ecosystem Group and also the Wales Biodiversity Policy Group, as well as meeting attendance.
- 3. LBAP groups to identify what guidance they need to undertake and complete the marine component of their LBAP reviews.
